1. Minor Course Revision: Originator – Mike Moran

HSV 220 Role of Substance Use Disorder Counselors (3 lec/0 lab) 3 sem hrs

Summary of Changes: The enforced prerequisites are being changed.

Rational: Prerequisite edit to "HSV 110, HSV 120, and HSV 210 or concurrent enrollment in HSV 210. Intent: students should have 110 and 120, and 210 can be completed prior or concurrent.

Impact: These changes only impact students enrolled in Human Services Programs 650A, 652C, and 655B.

Moran mentioned that HSV 210 can be taken concurrently to enable students to continue their degree progress.

2. Minor Course Revisions: Originator – Mike Moran

HSV 225 Clinical Skills for SUD Counselors (3 lec/0 lab) 3 sem hrs

Summary of Changes: The enforced prerequisites are being changed.

Rational: Prerequisite edit to "HSV 110, HSV120, and HSV 210 or concurrent enrollment in HSV 210. Intent: students should have 110 and 120, and 210 can be completed prior or concurrent.

Impact: These changes only impact students enrolled in Human Services Programs 650A, 652C, and 655B.

Moran mentioned that HSV 210 can be taken concurrently to enable students to continue their degree progress.

Saccone moved to approve these minor course revisions and Theobald seconded the motion. Hearing no objections, these minor course revisions will be **effective fall semester 2023**.

3. Course Withdrawal: Originator – Mike Moran

HSV 235 – Human Services Seminar/Field Experience (1 lec/3 lab) 4 sem hrs

Summary of Changes: HSV 235 is being withdrawn.

Rationale: The field experience requirements are covered by HSV 230 Addictions Counseling Seminar and Field Experience I and HSV 240 Addictions Counseling Seminar and Field Experience II.

Impact: None

Moran mentioned that HSV 230 and HSV 240 has replaced HSV 235. He also mentioned that it is not part of the post baccalaureate program.

Saccone moved to approve the withdrawal of HSV 235 and Theobald seconded the motion. Hearing no objections, this course will be withdrawn **effective fall semester 2023**.
