Minor Course Revision: Originator – Andrea Montgomery; Lisa Giese presented

Rationale: Course description updated to incorporate repeat standards and to clarify the examination preparation and age/ high school completion status for licensure.

EMT 120 Emergency Medical Technician - Basic

(8 lec/3 lab)

9 sem hrs

Summary of Changes: The course description and course notes have been updated.

DECISION FOR EMT 120:

Giese stated that updates were made to the catalog and handbook to reflect the examination preparation outcomes of the course with clarification on the age and high school completion status needed for testing.

Gorski moved for a motion to vote on this minor course revision for EMT 120. Theobald so moved and Saccone seconded the motion. The vote was called and passed. This minor course revision will be **effective Spring 2025**.

Minor Course Revision: Originator – David Voorhees

Rationale: Language updated and spelling errors edited for clarity. An additional course added in the recommended prerequisite to increase student enrollment options.

GLG 102 Historical Geology

Summary of Changes: Recommended prerequisite, course objectives, and course topics are being updated.

Voorhees explained that a new recommended prerequisite course was being added to expand student preparation paths for GLG 102.

Summary of Changes: Course title, course description, objectives, outcomes, and topics have been updated replacing Old Testament with Hebrew Bible.

Bickley stated that the title, course description, and outcomes have been updated to align with the IAI course descriptor that RLG 220 is approved under.

RLG 230 Christianity and the New Testament

Summary of Changes: Course description has been updated.

DECISION FOR RLG 230:

Bickley explained that the course description was updated to include current terminology within the field of religion studies.

Gorski moved for a motion to vote on this minor course revision for RLG 230. McDonald so moved and Theobald seconded the motion. The vote was called and passed. This minor course revision will be **effective Fall 2024**.
