#### 1. Minor Course Revision:

ART 100 Art Appreciation

3.0 sem hrs 3 lec/0 lab

Heather Weber, accompanied by Doug Jeppesen, presented updated course outcomes.

## 2. New Course:

HUM 108 World Mythology

3.0 sem hrs 3 lec/0 lab

Dr. Aaron Lawler and Steve Zusman presented this new course. The course content is a comparative introduction to mythology throughout the world, with a specific emphasis on non-Classical mythology. The nature of mythology will be examined through the study of themes in folklore, myth, and legendary narratives as well as the representation of those themes through the humanities. There is also a focus on archetypal figures/situations, symbolism, and figurative language found in creation stories, heroic legends and/or other traditional narratives.

The request to add this course to the Humanities curriculum is based largely on the success of a similar course, HUM 112 Greek and Roman Mythology. The scope of the new course will broaden the study of mythology to other parts of the world.

It was also suggested that the course, if approved, be cross-listed with the English course in comparative literature. Feedback to this suggestion included a request to use cross-listing in a cautious manner and only when absolutely necessary to avoid confusing students in their choice of courses.

In addition to the above, minor wording changes/corrections in the course outline were suggested. The two presenting faculty agreed to review and make these modifications.

In conclusion, Dr. Diane Nyhammer indicated that this was the first reading of a new course and will be brought back to the next Curriculum Council meeting for a vote on the second reading.

# 2. Program Withdrawal:

LGI 621C Legal Interpreting: English/Spanish Certificate of Achievement 16.5 sem hrs

Suzette Murray indicated that the LGI courses, all taught by adjuncts, lead to the completion of the specific LGI certificate only. As they do not stack into any other program, these courses are not taken unless a student intends to complete the LGI certificate. The program and courses are experiencing very low enrollment as students are permitted to become legal interpreters without this course of education. Currently, only four students are taking these courses with the intention of completing the LGI certificate, and they are all scheduled to do so soon. Unfortunately, no other students are entering the program. Therefore, due to low enrollment in the courses in general, and due to a program that is no longer needed to become a legal interpreter, the recommendation is for both the courses and the program to be withdrawn.

Shawn Ballee moved to approve the withdrawal of the courses and the withdrawal of the program; Elior Iseli seconded the motion. Hearing no objections, the course withdrawals and the program withdrawal were approved. Instructional Services will make application to the ICCB for the course withdrawals and the program withdrawal, effective fall semester, 2022.

## Business, Technology, and Workforce Education

WLD 200 Fabrication and Weld Design 3.0 sem hrs 2 lec/2 lab

Ne'Keisha Stepney, on behalf of Mark Gloudeman, indicated the necessity of changing the recommended prereq for this course, WLD 101, to an enforced

prereq. This enforced prereq will better prepare students for a successful outcome in WLD 200.
