*Summary of Changes:* CIS 117 was withdrawn from ICCB effective 08/15/2012 and the department would like to reactivate this course. Once approved by Curriculum Council, the Form 13 process will be initiated.

# **DECISION FOR CIS 117:**

Moriarty stated that this class is needed for a BS degree in Computer Science. He also stated the IAI code needs to be set.

Nyhammer moved for a motion to vote on this course reactivation of CIS 117. Theobald so moved and Fuller seconded the motion. The vote was called and passed. The next steps are receiving approval from ICCB, Form 13 articulation, then IAI. This course reactivation will be **effective Fall 2025**.

Argent stated the course description and outcomes are outdated and were updated to align with current practice.

Nyhammer moved for a motion to vote on this minor course revision for ANT 101. Saccone so moved and Theobald seconded the motion. The vote was called and passed. This minor course revision will be **effective Fall 2024**.

Major Course Revision: Originator – Emily Heller and Nicholas Grahovec (Course Trainer) *Rationale:* Changes in content delivery no longer requires lab.

#### KPE 150 Basic Prevention and Care of Athletic Injuries

*Summary of Changes:* Revision of lab/lec ratio from 2/2 to 3/0. This change requires ICCB approval.

# **DECISION FOR KPE 150:**

Changes in content required by the accreditor no longer requires a lab.

Nyhammer moved for a motion to vote on this major course revision for KPE 150. Christensen so moved and Fuller seconded the motion. This major course revision will be **effective Spring 2025**.

# Minor Course Revision: Originator – Pratima Jindal

Rationale: Prerequisite is being updated to better prepare students for this course.

# PHY 111 Introduction to Physics I

(3 lec/3 lab) 4 sem hrs Summary of Changes: Enforced prerequisite has been updated to "C or better in MTH 069..."

# **DECISION FOR PHY 111:**

Jindal stated the current prerequisite is probably much higher than what is needed and that changing the prerequisite requirement to MTH 069 would better prepare the students for the course. There was a discussion regarding whether the perquisite requirement should be MTH 067 instead of MTH 069.

Nyhammer moved for a motion to vote on allowing Jindal additional time to decide which perquisite should be required. Christensen so moved and Theobald seconded the motion. The vote was called and passed.
